





Conditions for warranty of damaged items * (You should read for your own rights and benefits)

- · We will consider repair first if there is any damage that cannot be repaired or compensated. The company will consider insurance for damage from moving up to 20% of the service fee and the actual cost of the damage of such items, which the claim party will assess and estimate the value for compensation.
- In case the service area is not in Bangkok and its vicinities, the amount of insurance for damage from moving costs is up to 10% of the service fee **Terms and conditions apply by the company.
- The company is not involved in the case of lost items. It will guarantee only damaged items from the actual moving on site only.
- Damage caused by work, such as caused by accidental, unintentional, or employee's mistake in the work (accident) will explain force majeure. The compensation will be based on actual and actual damage in the budget of the warranty limit.
- · damage caused the claiming party will assess and assess the value for compensation according to the amount of damage incurred in the maximum liability limit of not more than 20% of the actual service price. 
